The Unifor Family Education Program is funded by the National Union. There is no cost to the Local Union, and you are not required to have Paid Education Leave (PEL) negotiated in your collective agreements to have members participate in the program.

The program is open to members and their immediate families (spouse/partner and dependent children up to and including 18 years of age only). **Members are not eligible if they attended the Family Education Program within the last (7) seven years.**

Successful applicants will be notified by April 10th, 2026.

Posters have been included with this letter to help you promote the program. We have provided space on the poster for you to add your Local Union contact person, along with their contact information. Additionally, eligibility requirements and instructions are attached with this call letter.

Unifor Family Education Program

What is the Unifor Family Education Program?

This is a unique program where members and their families get to participate in a week of learning and recreational activities.

ADULTS will discuss current economic and social issues from a worker's viewpoint, as well as the history, structure and policies of our Union. We will also have a number of excellent guest speakers on topics that touch the lives of workers every day.

All sessions are held in a comfortable and very informal setting.

TEENS – 13 to 18 years, will be involved in their own program that will be geared to the concerns and issues of their age group. Again, the setting for their discussions is informal and relaxed.

CHILDREN – 4 to 12 years will have a program supervised by trained recreation counsellors with activities ranging from arts and crafts to games and sports.

CHILDREN – infants to age 3 will be cared for in the day-nursery, complete with infant daycare and preschool facilities - including sleeping accommodation, enclosed playground and qualified staff. Please note that infants must be enrolled in child care and will not attend the classroom sessions with parents.

Will there be family time?

Discussions in class generally run from 9:00 am to 4:00 pm. Evenings are free to enjoy an array of organized and unorganized recreation activities.

If this sounds like something you and your family are interested in, complete an application and submit before the registration deadline of Friday, March 13th. (See application to find out where to return your completed application.)

Eligibility Requirements and Instructions

- ✓ You are eligible to apply for the Family Education Program if you are a Unifor member in good standing and have a spouse/partner and/or children 18 years of age or younger. *(If you do not have a spouse/partner and/or children 18 years and younger to attend with you, you are not eligible – please investigate attending one of our Paid Education Leave Programs instead.)*
- ✓ You do not require Paid Education Leave [PEL] in your contract.
- ✓ You are **NOT eligible** to apply for the Family Education Program if you have attended within the last 7 years.
- ✓ **Unifor will provide, free of charge, food and lodging for each participant (and family member) during your stay at the Education Centre.**
- ✓ Each participant must contribute their time (vacation, personal leave, etc.). **NO LOST TIME, PER DIEM OR MILEAGE WILL BE PAID.**
- ✓ Each participant must come prepared to attend all in-class sessions. It is important that you discuss this with your family in advance of applying for the program.
- ✓ The program runs from Sunday dinner through to the following Sunday at approximately 11:00 am. **Early departures from the program cannot be accommodated.** Please ensure you can attend the entire program before applying.
- ✓ Plane tickets will be provided by the National Union (if you are traveling more than 500 kilometers one way, and choose to fly rather than drive).
- ✓ Those requiring an overnight stay while travelling to and from the Centre, will be provided with hotel accommodations. Costs for meals during this overnight stay are your responsibility.
- ✓ ***Please fill out the entire application form***, including date and signatures. Have it signed by your local union President or Financial Secretary and **return all 3 pages of the application by Friday, March 13th to:**
